## STEPS FOR REQUESTING CLEARANCE CHECKS

(Criminal/Police Clearance, Traffic Clearance, Traffic Record History)

### (Requestor)

1. Complete the following form:
  - a. Court Clearance Request Form
2. Submit a scanned copy of an approved form of ID.
3. Email all required documents, including the scanned copy of ID to [Superior.Court@NMJudiciary.gov](mailto:Superior.Court@NMJudiciary.gov) and/or [Novelyn.WaniaTenorio@NMJudiciary.gov](mailto:Novelyn.WaniaTenorio@NMJudiciary.gov)

### (Clerk of Court)

1. The request will be received via email. The Clerk will review the submission to ensure all required documents are complete.
2. The Clerk will prepare a payment slip for the cashier and instruct the requestor to contact the cashier at 670-236-9790 to make payment over the phone.
3. Conduct research for the clearance/history.
4. Once the research is complete, email a copy of the clearance and receipt to the requestor and place the original document in the pickup box.
