- 8 (b) The guilt of either party toward the other of such cruel treatment, neglect
9 or personal indignities, whether or not amounting to physical cruelty, as to
10 render the life of the other burdensome and intolerable and their further
11 living together unsupportable.
- 12 (c) Willful desertion continued for a period of not less than one year.
- 13 (d) Habitual intemperance in the use of intoxicating liquor or drugs
14 continued for a period of not less than one year.
- 15 (e) The sentencing of either party to imprisonment for life or for three years
16 or more After divorce for this cause, no pardon granted to the sentenced
17 party shall affect the divorce.
- 18 (f) The insanity of either party where the same has existed for three years
19 or more.
- 20 (g) Irreconcilable differences, which are persistent and irresolvable
21 disagreements between spouses that results in the breakdown of the
22 marriage. Irreconcilable differences may be cited generally without citation
23 of specific differences, as ground for dissolution of the marriage.

- (i) Willful neglect by the husband to provide suitable support for his wife
when able to do so or when failure to do so is because of his idleness,
